



#### Alvey – the noble friend of elves

"But the Quendi shall be the fairest of all earthly creatures, and they shall have and shall conceive and bring forth more beauty than all my Children; and they shall have the greater bliss in this world"

— <u>Ilúvatar</u> in <u>Quenta Silmarillion</u>, "<u>Of the Beginning of Days</u>"

• The Elves were the first and the most powerful children of Eru Ilúvatar, supreme deity and creator of Arda, commonly referred to as Earth. Self-titled as the Quendi ("the Speakers") [1], but habitually known to as Eldar, the Elves were frequently appraised for their illustrious beauty and intelligence among other earthly creatures. The Elves differentiated themselves from other races through their immortality; they were unsusceptible to illness and old age, thus, could only be killed by blade or desolation. They were willowy, elegant and dignified yet powerful, agile and adroit. They were undaunted and adventurous with a keen will for discovery and learning. [The Quendi] "lived in places of ethereal beauty; in the midst of ancient forests or in silvery spires glittering with [effulgent] light". [2] Proficient fighters, they exceled in ranged combat with the bow as the weapon of choice. Unfortunately, most Elves left for the Undying Lands, yet there are some that believe that few remain among us as "Lingerers" [3], invisible to the mortal eye, roaming and protecting the realm.



If we descend upon the mortal websites of myth and legend, we discover that the elf "(Old Norse: álfr, Old English: ælf, Old High German: alb, Proto-Germanic: \*albaz) is a certain kind of demigod-like being in the pre-Christian mythology and religion of the Norse and other Germanic people. [They] are luminous beings, more beautiful than the sun, whose exalted status is demonstrated by their constantly being linked with the Aesir and Vanir gods in Old Norse and Old English poetry... The worship of the elves persisted centuries after the Germanic people's formal conversion to Christianity as medieval law codes prohibiting such practices demonstrate. Ultimately, then, their veneration lasted longer than even that of the gods." [4]

#### Meaning of the Name Alvey

Elf / Noble Friend

Diminutive of Alvin: Wise friend. From the Old English Aetheiwine, and also Aefwine, both meaning noble friend. [5]

WHAT IS ALVEY?

Alvey Coin is a decentralized blockchain project built on Bitcoin's UTXO model, with support for Ethereum Virtual Machine based smart contracts, and secured by a proof of stake consensus model. It achieves this through the revolutionary Account Abstraction Layer which allows the EVM to communicate with Alvey Coin's Bitcoin-like UTXO blockchain.

This is the main network where the tokens hold value and should be guarded very carefully. If you are testing the network, or developing unstable software on AlveyCoin, we highly recommend using either testnet or regtest mode.



#### The major features of the Alvey Coin network include:

- Compatibility with the Ethereum Virtual Machine, which allows for adjustment with most existing Solidity based smart contracts. No special solidity compiler is required to deploy your smart contract to Alvey Coin.
- A Proof of Stake consensus system which is optimized for Alvey Coin's contract model. Any user can stake and help to secure the network. There is no voting, master nodes, or minimum amount required. There have been transactions as small as 2 Alvey Coins that have created blocks in the past. Staking from smart contracts is under development.
- The Decentralized Governance Protocol is completely implemented and functional, which allows certain network parameters to be modified without a fork or other network disruption. This currently controls parameters like block size, gas prices, etc.
- Uses the UTXO transaction model and is compatible with Bitcoin, allowing for existing tooling and workflows to be used with Alvey Chain. This allows for the infamous SPV protocol to be used which is ideal for light wallets on mobile phones and IoT devices.





### WHAT IS ALVEY COIN CORE?

Alvey Coin Core (A.C.C) is our primary mainnet wallet.

It implements a full node and is capable of storing, validating, and distributing all history of the Alvey Chain. A.C.C is considered the reference implementation for the Alvey Coin network.

#### **Alvey Coin Core currently implements the following:**

- Sending/Receiving ALV coins
- Sending/Receiving ARC20 tokens on the Alvey Chain
- Staking and creating blocks for the Alvey Chain
- Creating and interacting with smart contracts
- Running a full node for distributing the blockchain to other users
- "Prune" mode, which minimizes disk usage
- Regtest mode, which enables developers to very quickly build their own private Alvey Coin network for Dapp testing
- Testnet mode, using the public Alvey Coin Testnet, with faucet available
- Compatibility with the Bitcoin Core set of RPC commands and APIs
- Full SegWit capability with p2sh-segwit (legacy) and bech32 (native) addresses.



## Alvey Smart Contracts:

We introduce the Alvey framework for a smart contract blockchain technology solution. Alvey integrates the Ethereum virtual machine (EVM) along with Bitcoin's unspent transaction outgoing protocol. The use of unspent transaction outputs is more scalable than other blockchains. In addition, Alvey chain framework recognises that smart contract lifecycle management is important to support proper security research by collaborating parties. The Alvey framework has a clear understanding of the quality criteria that future developments must satisfy and recognizes that smart contracts are sociotechnical artifacts that must also take into account the quality requirements essential to achieve widespread adoption by users.


